Qualifications:

Age: The age of the candidates shall not exceed 45 years as on the date of the Interview

Educational qualifications:

For Law Subjects: The candidate must have a Master's degree in Law with 55% marks (Or an equivalent grade in a point scale wherever the grading system is followed) with UGC NET or Ph.D in Law from any Recognized University. However in case of non availability of UGC NET or Ph.D candidates or found unsuitable by the selection committee, the candidates from other categories having a Master's degree in Law with 55% marks—can be considered.

For History, English, Sociology, Public Administration, Political Science and Economics: The candidate must have a Master's degree with 55% marks (Or an equivalent grade in a point scale wherever the grading system is followed) in a concerned /relevant/allied subject with UGC NET/ Ph.D in their respective Subjects from any Recognized University.

However, the selection shall be based on the candidate's subject knowledge, Communication Skill. Performance in the demo class and interview.

Tenure of Engagement: The tenure of engagement of Guest faculties shall be purely temporary and valid for a maximum period of one academic session (June 2025 to May 2026). The continuation of engagement will be subject to satisfactory performance, which will be evaluated during the Semester wise review.

Honorarium: Rs. 1000/- Per Class (1hour duration) subject to maximum 40 Classes for each subject. The Payment will be processed only upon certification of completion of the full course and submission of the relevant Remuneration Bill. No other allowances financial benefits except honorarium shall be allowed in favour of the Guest faculties.

Duties and Responsibilities of the Guest faculty:

- The faculties are required to stay full-time during office hours of the College, if they are assigned more than 80 classes in a semester.
