WALK-IN-INTERVIEW FOR GUEST FACULTIES AT ULC

A walk-in-interview will be conducted for tenure based temporary engagement of 8 numbers of Guest faculty for one year in the rank of Assistant Professor on class wise remuneration for 5 year BA LLB (H) Course at University Law College, Vani Vihar under Utkal University.

Interested candidates may visit the University Law College website ulc.ac.in for details of qualification and other terms & conditions etc.

The eligible candidates are advised to report at the P.G. Council, Hall, P.G. Central Office on 6th September 2024 at 10.30 a.m. for attending the walk-in-interview.

They are also required to bring all original documents /certificates for verification.

No T.A , D.A. shall be paid to the applicants to attend the interview.

The authority reserves the right to reject and cancel applications of any or all the candidates without assigning the reason thereto.

Educational qualifications

1. The candidate must be a holder of Master's degree in Post Graduate in Law with at least 55% of marks or equivalent grade from a recognized University for general candidates and 50% of marks or equivalent grade in case of SC ST/PH candidates having clear NET conducted by UGC or who have been awarded a Ph. Degree in accordance with UGC .
2. Non-net and non-Ph-D candidates shall be considered only in case of non-availability of UGC qualified candidates. However the preference can be given to the applicants those who are qualified the National Eligibility Test(NET) in Law or Ph. D Degree in law.

Tenure of engagement

1. The tenure of engagement of guest faculties under this arrangement shall be a maximum period of one year at a time.
2. The continuation of engagement shall be subject to satisfactory performance during the quarterly review. Cond....

Honorarium

1. The honorarium shall be paid to the guest faculty on class wise remuneration @ Rs. 750/- per class with duration of 1 hour for 5 year BA LLB (H) Course under self-finance mode at University law College subject to maximum- 40 classes per month. No other allowances /financial benefits except honorarium shall be allowed in favor of the Guest faculties.
2. The payment of all statutory deductions including tax deduction at source (TDS) will be deducted by the University law college against the payable remuneration at applicable rate as per the prevailing laws, rules and regulations.

Duties and responsibilities of a engaged faculty

1. The faculties have to stay full time during the office hour at ULC
2. The faculties engaged under this arrangement shall have the following additional duties and responsibilities over and above as mentioned against work assignment above.
3. Academic work like teaching courses conducting examination and research guidance and any other work assigned as per requirement.
4. Launching continuing education programme in new and emerging areas. Organizing /attending National /International Conferences/seminars/Symposia/ Workshop by without any financial commitment from the University Law College.
5. Participation in academic/research committees at University law college and elsewhere when required.
6. However, they shall not eligibles for holding administrative and financial responsibilities.

Review of performances

The performance of the guest faculties under this arrangement shall be reviewed on quarterly basis by the University. If the performance/ official conduct is found unsatisfactory, then he/she may be disengaged forth with by the principal, ULC furnishing a report to the Vice- Chancellor of the Utkal University.


